

Terms and Conditions

- **Introduction**

These Terms and Conditions govern your participation in the [Tahiti Summer Game] (the "Competition"). By entering the Competition, you agree to comply with and be bound by these Terms and Conditions. If you do not agree with any part of these terms and conditions, you will not be eligible to participate in our competition.

- **Eligibility**

The Competition is open to individuals who are 18 years or older as of the date of entry.

Participants must register to BrandActiv game portal to participate and need to be residing in Mauritius

- **Timeframe**

The entry period begins on Friday 20th December 2024 at 6pm and ends on Sunday 5th January 2025 at 6pm

This game does not have a limit on the number of trials or hours played.

- **Competition Rules**
